1. Engagement

4. Project based payments

Specific projects are paid separately from the monthly compensation and depend on delivery and finalization.

Included within the current cooperation are the Loodgieter.app project and the EasyRed website.

Additional projects require separate approval and may result in additional payments based on scope, delivery, and results.

5. Ongoing work

The Contractor has already been actively working with The EasyRed Team SL prior to this agreement. This contract formalizes the existing cooperation.

6. Confidentiality

All source code, credentials, documentation, internal communication, and business information are confidential and remain the exclusive property of The EasyRed Team SL.

7. Intellectual property

All work, code, designs, documentation, and deliverables created during the cooperation become the sole property of The EasyRed Team SL upon payment.

8. Communication and availability

The Contractor agrees to maintain regular communication and provide progress updates as requested by The EasyRed Team SL.

9. Termination

Either party may terminate this agreement with 7 days written notice. Work completed up to the termination date will be compensated proportionally.

10. Governing law

This agreement is governed by Spanish law. Jurisdiction is Santa Cruz de Tenerife, Spain.
